## **Conditions of the Adoption**

All clauses of this contract must be agreed to by signing and dating.

## The Adoptive Family

- 1. Adoptive family agrees that this cat/kitten will be given ample amounts of love, attention and entertainment and will be treated with love and respect at all times.
- 2. Adoptive family agrees that this cat/kitten will not be struck or in any way mistreated or abused. Any breach will result in the animals' immediate and unconditional return to the breeder without cost to said breeder.
- 3. Under no circumstances will this kitten/cat be declawed.
- 4. Adoptive family agrees to care for this cat/kitten with the best diet possible, fresh water at all times, clean housing and a good standard of veterinary care including up to date vaccinations and parasite prevention. Failure to do so will result in the voiding of any guarantees issued by the breeder.
- 5. Adoptive family must seek veterinary advice immediately if this cat/kitten shows signs of illness or distress.
- 6. The adoptive family acknowledges that kittens/cats may exhibit some form of stress due to the transition from the breeder's home to their own. This may take the form of anxiety, lack of appetite, sneezing or snuffling. The breeder will not be responsible for illness or costs incurred due to transitional stress
- 7. Under no circumstances (except for humane reasons) is this cat/kitten to be euthanized unless prior notification has been given to the breeder. In which circumstance the breeder has the right to resume ownership of the cat/kitten.

- 8. The cat/kitten **must** be kept **indoors** at all times unless in a **safe and secure enclosure**, or **in an cat approved harness**. The breeder may ask for photographic evidence or ask to inspect the cat/kittens living accommodation.
- 9. Exposure to hazards and diseases (both indoors and outdoors) will void any guarantees or options for replacement.
- 10. Under no circumstances will this cat or kitten be sold, leased or given away to any pet store, research laboratory, breeding mill or similar facility.
- 11. If the adoptive family can no longer provide a home for said cat/kitten, the adoptive family must inform the breeder who will endeavour to help rehome the kitten. The adoptive family understands that there will be no refund of costs or adoption fee by the breeder.

## The Breeder

- 1. The breeder reserves the right to refuse an adoption at any time and for any reason.
- 2. Deposits are non-refundable unless the breeder is in agreement.
- 3. The breeder guarantees that this cat/kitten is healthy to the best of her knowledge. This kitten is guaranteed for 72 hours against, but not limited to the following ailments: upper respiratory infection, internal and external parasites, and FELV/FIV.
- 2. The Adoptive family has 72 hours to take the kitten to the vet for a health exam, if any health concerns are found, the adoptive family may return kitten to the breeder within that time with an explanation from the attending vet. No medical or travel charges will be refunded. During this first 72 hours the kitten should be isolated from any other pets and monitored for health, eating, litter box usage and activity level.

- 3. The breeder is not responsible for any injury or illness to other pets caused by exposure to this kitten.
- 4. If the kitten/cat dies within the first year of life due to an inherited genetic disease, the adoptive family must inform the breeder and provide an autopsy from a certified veterinarian. The breeder will then replace said kitten with one of equal quality when one becomes available.
- 5. The breeder will provide the adoptive family with the registered pedigree of the cat/kitten within 2 months.
